## PNA Review: Application by Capsaris Ltd to deliver new services in Fieldway Pharmacy

## Supplementary statement to NHS Croydon's pharmaceutical needs assessment

Date pharmaceutical needs assessment published – 1<sup>st</sup> February 2011 Date supplementary statement issued – 29<sup>th</sup> March 2012

The pharmaceutical needs assessment of NHS Croydon identified in Section2 Parts 1&2 that:

- Fieldway is the most deprived ward in the whole of South West London and amongst the 15% most deprived in England
- It has above average numbers of teenage mothers and people aged 55+.
- In New Addington and Selsdon the pharmacy opening hours per 1000 items dispensed was 42.6 compared to an average of 46.2 for all Croydon (note this average did not include the new LPS pharmaceutical service in Mayday, which will increase the Croydon average)
- The number of dispensing staff per 1000 prescription items was low at 21.6 compared to 26.5 for all Croydon (note this average did not include the new LPS pharmaceutical service in Mayday, which will increase the Croydon average)
